

ESCOLAR Project Website Terms and Conditions of Use

These Terms and Conditions of Use (“Terms of Use”) apply to the University of Oregon’s (“UO”) ESCOLAR Project Website located at __escolar.tech__ and all associated sites linked to that site by the University of Oregon (collectively, the “Site”) provided by the UO on behalf of its Center for Equity Promotion for the ESCOLAR Project. BY USING THE SITE, YOU AGREE TO THESE TERMS OF USE.

- 1. Terms of Use Updates.** The UO reserves the right to change, modify, add or remove portions of these Terms of Use, at any time. It is your responsibility to check these Terms of Use periodically for changes. Your continued use of the Site following the posting of changes will mean that you accept and agree to the changes.
- 2. Ownership of Content.** The UO owns, controls or has a license to all text, graphics, user interfaces, visual interfaces, photographs, trademarks, logos, sounds, music, artwork computer code, and educational materials (collectively, “Site Content”), including but not limited to the design, structure, selection, coordination, expression, “look and feel” and arrangement of such Site Content, contained on the Site, and the UO’s interest in the Site Content is protected by applicable law.
